<u>Regarding the Municipal Taxes / Environmental Taxes</u> (Resident Tax 住民税) of Foreign Residents Living in Japan

• Municipal Taxes / Environmental Taxes are taxes paid to the municipality where you live on January 1st.

• Even if you are a foreigner, you need to pay Municipal Taxes / Environmental Taxes.

• When your tax payment slip (納税書) arrived with your payment notice (通知書), please be sure to pay by the deadline written on it.

• If you use bank transfer, please check your payment notice (通知書) for any mistakes.

- A penalty may be added to your fees If you do not pay the municipal tax by the deadline.

Reminders

• Even if you live in another city now, if you lived in Nishio City on January 1st, your tax is paid to Nishio City.

• Your Municipal Taxes / Environmental Taxes are calculated based on your income from January 1st to December 31st of last year. Even if you don't work now, your Municipal Taxes / Environmental Taxes may be generated if you worked last year.

• Even if you' re leaving Japan, you need to pay your Municipal taxes / Environmental taxes if you were in Nishio City on January 1st. Please be sure to pay your Municipal taxes / Environmental taxes before leaving Japan. If you cannot pay your Municipal Taxes / Environmental Taxes before leaving Japan, please appoint a person who carries out tax payment procedures on your behalf (tax agent 納税管理人).

Tokubetsu Choshu(特別徴収)

- Under this system, your company will collect Municipal Taxes and Environmental Taxes from your monthly salary and pay them to the city on your behalf.
- Your yearly Municipal Taxes and Environmental Taxes payments will be divided into 12 installments and collected from your salary from June to May of the following year.
