

## To Resident Tax-exempt Households

### FY 2024 Information on the Price Inflation Assistance Benefits

**Applications are required to receive these benefits.**

Households with dependent children who are 18 or younger are eligible for the additional amount indicated in item 2 on top of the amount stated in item 1.

## 1. Price Inflation Assistance Benefits Application Form

### (1) Eligible Households

Households registered in Nishio City as of the reference date (December 13, 2024) and exempt from Resident Tax for the FY 2024.

- ① Households that have no member with undeclared Resident Taxes and are deemed to possibly be eligible to receive the benefits → A Benefit Eligibility Verification Form will be enclosed.
- ② Households with members who have not yet declared their Resident Tax and are deemed to possibly be eligible to receive the benefits → An application form will be enclosed.

\*Resident Tax-exempt households in which all members are dependent on a relative(s) subject to the per capita rate Resident Tax are not eligible for the above benefits. (No benefits will be provided.)

### (2) Benefits

¥30,000 per household \*The benefits is legally protected against seizure and exempt from taxation.

## 2. Price Inflation Assistance Benefits - Supplement benefits for children

### (1) Eligibility

Eligible households that satisfy one (1) of the requirements in 1 above, are providing for a child 18 and below, and meet the two (2) requirements below.

- ① For households with children 18 or younger in the same household, make sure that the names on the Benefit Eligibility Verification Form are accurate.
- ② A separate application must be submitted to apply for Children born before May 31, 2025, whose names have not been included in the Benefit Eligibility Verification Form.

## **(2) Requirements for Eligible Children**

- ① Children 18 or younger (born on or after April 2, 2006) and children born between December 14, 2024, and May 31, 2025 (a separate application will be required) who belong to the same household as the above-mentioned eligible applicant as of the reference date (December 13, 2024).
- ② Eligibility means children under 18 who belong to a different household but are dependent on the eligible applicant.

(e.g.) When a dependent child lives alone in a dormitory, etc.

\*Institutionalized children are not eligible for the benefits.

Children residing in facilities such as children's homes are not eligible (no benefits will be provided), regardless of whether their registration of residence has been transferred from an eligible household to the facility or not.

## **(3) Benefits**

¥20,000 per child \*The benefits is legally protected against seizure and exempt from taxation.

## **Application Instructions**

**【 For those submitting a Benefit Eligibility Verification Form】**

**Send the Benefit Eligibility Verification Form**

with the enclosed return envelope via the post office or bring it to Nishio City Hall's reception desk in person.

**【For those submitting an application form】**

Send the application form with the necessary documents via the post office or bring it to Nishio City Hall's reception desk in person.

**\*Applicant households with children born on or before May 31, 2025, must submit a separate application to claim the child's portion of the benefits for children after submitting the application form and the Benefit Eligibility Verification Form.**

**\*Make sure to attach all required supporting documents, if any.**
